JUNE 8, 2020 LICENSE COMMITTEE MINUTES**

Pursuant to due call and notice thereof, a meeting of the license committee was held Monday, June 8, 2020 at the Municipal Building 800 Borner St. Prescott, WI 54021

Call to order/Roll call: Alderperson Oss called to order at 5:30 p.m. Members present were Dar Hintz, Joshua Gergen appeared in person. Thomas Oss appeared online. City Administrator Jayne Brand representing staff.

Hintz/Gergen motion to approve the minutes for April 6, 2020 passed without a negative voice vote.

Hintz/Gergen motion to approve cigarette licenses for 2020-2021 for Bob & Steve's BP Amoco Shop, Leo's Landing, Holiday, Express Lane, Ptacek's IGA, Churchill Market, St. Croix Liquor, Croix Distributor, Inc, and Dollar General passed without a negative voice vote.

Gergen/Hintz motion to approve amplifier permits for 2020-2021 for Muddy Waters, Lucilles, Philanders and Scabs passed without a negative voice vote.

Gergen/Hintz motion to approve sidewalk café applications for 2020-2021 for Kitchen Table, Muddy Waters, Papa Tronnio & Twisted Oak Coffee Shop passed without a negative voice vote.

Hintz/Gergen motion to approve operator licenses for Geraro Cardenas, Adam Balsimo-Schnide, Alex Arntson, Isabelle Petit, Jennifer Grossell and Joseph Roosen passed without a negative voice vote.

Larry Johnson presented his request for a Class "B" combination license. They plan on making a portion of the building into a restaurant. Larry stated it did not make sense to start a project until he knew that they would be able to get a license. Alderperson Oss asked to see the proposed drawing before he could make a decision.

Gergen/Hintz motion to approve Class "B" combination license as presented with the exception of Pt. St Croix Marina and St. Croix Liquor LLC passed without a negative voice vote.

Gergen/Hintz motion to approve Class "A" combination licenses, Class "B" beer license except for Crazy about Baseball, Class "B" beer & Class "C" wine licenses and Class "A" beer and Class "A" (Cider Only) as present for 2020-2021 passed without a negative voice vote.

There has been a request from No Name Saloon to extend their license premise to their vacant lot. Alderperson Hintz was not in favor of extending the license premises, Alderperson Gergen was in favor of extending the license premises and Alderperson Oss would be willing to look at the extension as long as it was fenced and there were no vehicles parked in there. A question arose if there would be enough bathroom facilities with the extension. City Staff will review this further.

Normally all debts to the city needs to be paid before a license can be issued. There are several businesses who still have open debts with the city and staff wanted to know if the committee wanted to waive the requirement to have debts paid due to the coronavirus. License committee would like to see an effort made to pay the debt even if it means setting up a payment plan.

Gergen/Oss motion to adjourn passed without a negative voice vote.

Need a little help here it's been a rough stretch with robbery and all.

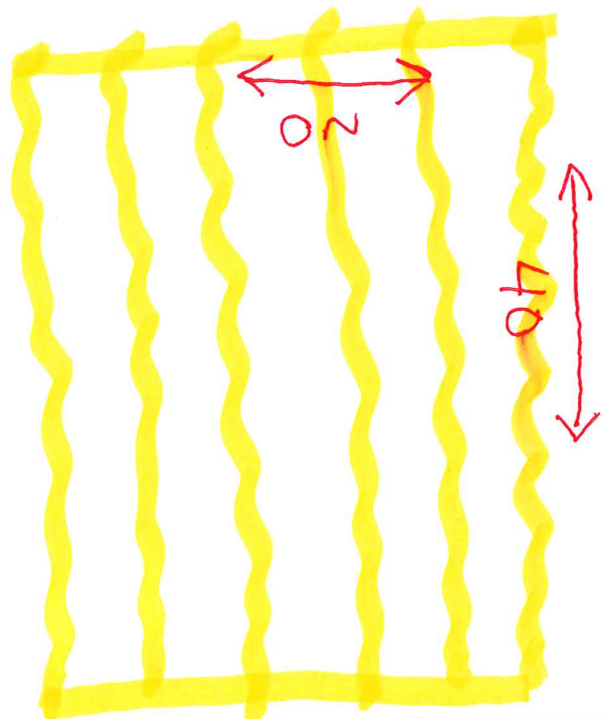
