RESOLUTION DESIGNATION PUBLIC DEPOSITORIES

BE IT RESOLVED, the following being qualified public depositories under Chapter 34 of the Wisconsin Statutes shall be and are hereby designated as public depositories of all public moneys coming into the hand of the City of Prescott:

First National Bank of River Falls

That the withdrawal or disbursement from any one of the above named depositories shall be made in accordance with Section 66.0607 of the Wisconsin Statutes: with all checks signed by two (2) of the following persons: David B.
